How can DIT academic staff use Webcourses data and reporting to make better informed decisions around student learning?

- 1. What does this study involve and does it impact my assessments in the module?
 - This study will in no way impact on your assessment/exam results. The focus of this study is not the student(s), the objective is to evaluate the analytics features within Webcourses.
 - All data related to staff and students within this study is strictly anonymous.
 - This study will be comparing how the reports generated within webcourses compare to your module results within webcourses. The kind of reports I will be looking at will include
 - Login statistics on webcourse
 - Time spent viewing content on webcourses
 - Number of postings on wikis, discussion forums (if your lecturer is using them)
 - Data related to quizzes, assessments within webcourses and how this compares to student engagement.
- 2. What is required of me as a participant in this study?
 - In order for me to conduct this study I need access to student within webcourses. If you wish to participate in this study then I require your signed consent so that I can view your data and assessment results within webcourses. Please note at no point will your identity be disclosed to any other student or lecturer. All student data will be de-identified.
- 3. Does my lecturer already have access to these reporting features in Webcourses? Yes your lecturer already has access to these reporting features within Webcourses and can generate reports based on his/her student cohort at any time. This study is an evaluation of these reports and further in-depth analysis of this data to see what information, if any we can obtain from Webcourses.
- 4. Will my webcoures data be kept confidential, secure and my identity protected at all times? All information relating to students in this study will be keep strictly confidential and all student records will be anonymised. At no stage will a student's identify be disclosed to their respective course tutor or any other individual. The privacy and welfare of students will be paramount at all times. Data related to this research will be stored in a safe location whereby only the researcher will have access to it. In addition, this data will be encrypted using DIT Mc Afee Endpoint

Encryption software. Any data saved to a USB or memory key relating to the research project will also be encrypted

Participation in this study is completely voluntary and participants are free to withdraw from this study at any time, without giving a reason for withdrawing and without affecting their future relationship with D.I.T
